

Portfolio Service

The Portfolio Service is designed for clients who wish to retain control over investment decisions and wish to receive regular information on the value of their portfolio.

The Portfolio Service provides:

- Discuss and determine your investment portfolio strategy with you (optional)
- Review all investments including shares, term deposits, fixed interest securities, listed and unlisted property trusts and unlisted managed funds
- Send you a weekly email detailing your portfolio valuation with Burrell Stockbroking (does not include corporate actions or unlisted investment transactions)
- Send you each quarter the value of your portfolio based on CHESS
- Access your Cash Management Account for investment moneys and dividends
- Deposit monthly or quarterly income payments to your bank (if required)
- Tax file numbers advised to registries (please note: most but not all registries accept electronic notification of tax file numbers)
- Send you/your accountant a summary of transactions for the year including broking ledger and contract note listing

- Send you our monthly Burrell Bourse bulletin covering Research Analyst's Market View, the Advisor Watchlist, Company News & Updates, Burrellblog, Yield News, Fixed Interest Summary
- Send you our Daily Research Notes email covering overnight News, Company Research, Market Insights, Company Updates
- Send you Burrell Alerts emails detailing opportunities arising from current market activity if appropriate to your portfolio.
- Provide you access to our regular Managing Director's blog that presents an independent and informed view of market happenings
- Provide ad hoc research as requested by you

Managed Funds

Managed funds purchase costs are reduced from the standard 4-5% industry rate to 2.2%. There is a nil cost for Managed funds redemptions.

Portfolio Service Fees

Managed funds investments (1-4 Managed Funds held: additional \$110 p.a.; 4 or more: additional \$220 p.a.)
